<u>Quality Education Fund e-Learning Funding Programme –</u> Provision of Mobile Computer Devices and Internet Services Support

Dear Parents/ Guardians,

To support students in their e-learning, the school will apply to the Quality Education Fund for funding to purchase iPad tablets **for loan** to students with financial needs and to provide portable WiFi routers and mobile data cards for students who are unable to acquire appropriate Internet services due to their constraints of the living environment.

1. Eligibility for borrowing tablets:

- 1. For students who have not received subsidy from the Community Care Fund (CCF) Assistance Programme for purchasing a mobile computer device, and are receiving Comprehensive Social Security Assistance (CSSA) from the Social Welfare Department, or full/half grant of the School Textbook Assistance Scheme (STAS) from the Student Finance Office.
- 2. For students who have not received subsidy from the CCF, and whose families face financial difficulties but are not receiving CSSA or STAS due to special circumstances. (They need to provide schools with explanations or supplementary information.)
- 3. For students who received subsidy from the CCF, and the device has been used for more than three years and is unable to operate.
- 4. For students who received subsidy from the CCF. The device runs a different operating system and thus cannot meet the schools' requirements. (Please refer to Note 3)

2. Eligibility for WiFi routers and mobile data cards support:

- 1. For students who are receiving Comprehensive Social Security Assistance (CSSA) from the Social Welfare Department, or full/half grant of the School Textbook Assistance Scheme (STAS) from the Student Finance Office and are unable to acquire appropriate Internet services due to their constraints of the living environment.
- 2. For students whose families face financial difficulties but are not receiving CSSA or STAS due to special circumstances (They need to provide schools with explanations or supplementary information.), and are unable to acquire appropriate Internet services due to their constraints of the living environment.

Notes:

- 1. The tablets under this program must be purchased by the school, and their **ownership belongs to the school**, tablets are loaned to eligible students, and **must be returned** upon graduation or withdrawal.
- 2. Students must follow the Acceptable Use Policy. (AUP) (See Appendix 1)
- 3. The operating system for tablets used in the school is: iPad OS.

Please complete the reply slip and return it to the class teacher on 25/10/2021. Students who would like to borrow the equipment should submit the reply slip together with a copy of the eligibility proof. In case students are yet to be notified of their CSSA or STAS application result, they should complete the reply slip and return it on or before 25/10/2021 and then submit the letter of result notification from CSSA or STAS by 1/2/2022 to the class teacher. Introduction

As new and emerging technologies continue to change the world we live in, they provide an opportunity for many unique and positive educational benefits to the classroom.

It is important that students and parents are familiar with the terms under which these devices can be used within the E.L.C.H.K. Hung Hom Lutheran Primary School.

Filtering and Monitoring:

E.L.C.H.K. Hung Hom Lutheran Primary School filters contents for student access on the Internet. However at times, inappropriate material may get past the filters and be viewed by the student. Students should report the occurrence to their teachers. Students will be held accountable for any deliberate attempt to bypass the filters and security.

E.L.C.H.K. Hung Hom Lutheran Primary School reserves the right to monitor, inspect, access and review all devices, which includes but not limited to personal emails and Internet access.

Guidelines:

Below are guidelines for students using their personal devices around campus:

- 1. The school is not liable for any loss, damage, or thievery of devices brought to school.
- 2. Students can only use school approved devices under teachers' supervision or with their approval.
- 3. Students can use their devices for educational purposes only.
- 4. All applications must be downloaded and installed through the school.
- 5. Students are prohibited from modifying their devices illegally.
- 6. Students can only email or communicate with others through their devices on school campus with teachers' permission.
- 7. Students cannot use their device for inappropriate communications. These include but are not limited to the following: harassing, bullying, threatening, personal attack, obscene, vulgar language or images that may cause damage to an individual or the school.
- 8. Students are prohibited from photo-taking or video/voice recordings without their teachers' permission.
- 9. Students can only listen to audio files with teachers' permission on school campus with in-ear headphones.
- 10. Students can only access the Internet via the school's wireless network and not their private mobile networks (e.g. 3G/4G).

Consequences for Violations:

Bringing your own device is a privilege and not a right. Students who do not observe the guidelines will face school disciplinary action and lose the privilege to utilize their devices for a period of time.

If reasonable belief exists that the student has violated the terms of this agreement, or other school policy, the student's device may be inspected and/or confiscated.

Any student violating the terms of this agreement will receive punishment(s) including warnings, demerit(s), and/ or forfeiture of the rights to bring their devices to school.

The school reserves the right to impose higher level sanctions at any time depending on the nature of the violation.
